Increased fines for dangerous driving offences



In response to concerns about dangerous driving behaviours on Yukon highways, the Government of Yukon is taking swift action to deter these offences and improve traffic safety.

We are doing this by implementing the *Traffic Safety Act*'s higher fines for dangerous driving offences. These new fines will take effect on July 1, 2025, while the full *Traffic Safety Act* will come into force later.



Why increase fines?

One of the best ways to deter dangerous driving behaviour is with immediate consequences. For years, the fines for dangerous driving in the Yukon have remained unchanged and no longer reflect the seriousness of the risk.

The new regulations are designed to better deter dangerous behaviour and protect the well-being of all people on Yukon highways.

What offences will have increased fines?

The following offences will see increased fines. The list only includes offences where fines are increasing, not all possible offences.
