AUTHORITY & MODES OF DELIVERY

OGA S.8 and 21 OGDR S.1 (Interpretation), 13, 14

According to the YOGA, and the *Oil and Gas Disposition Regulations* (OGDR), the holders of a disposition must designate a representative by giving notice to the Minister. Notice must also be given if a designated representative is to be replaced or revoked. The *Notice of Designated Representative*, *Replacement*, *or Revocation* may be delivered to Oil and Gas Resources branch by hand, courier, mail, fax, or e-mail. Notices are registered in the order they are received at the branch.

WHAT IS A DESIGNATED REPRESENTATIVE?

In relation to an oil and gas disposition, a designated representative is the person authorized to represent the holder or holders of a disposition. In respect to all matters arising under the disposition, holders are bound by the acts and omissions of the designated representative.

WHY DESIGNATE A REPRESENTATIVE?

Every disposition must have one designated representative. From time to time staff at Oil and Gas Resources may have contact with disposition holder(s) via the designated representative to provide notices and documents that are required or authorized according to the YOGA or any regulations under it. These documents must be delivered to the designated representative at the official service address registered to the disposition. The designation of a representative will remain in effect until



it is replaced or revoked. It is the responsibility of disposition holders to keep these records up to date with the Oil and Gas Resources branch.

WHEN THERE IS NO DESIGNATED REPRESENTATIVE

If a disposition has more than one holder and no representative has been designated, the Minister may designate one of the holders as a representative. If a sole holder of a disposition does not designate a representative, the sole holder is the designated representative.
